# ONE DAY EDUCATION PROGRAM SINDHUPALCHOWK DISTRICT CHAPTER

#### **District Profile**

Sindhupalchok District is a part of Province No. 3 and one of the seventy-seven districts of Nepal, with an area of 2,542 km²(981 sq mi). The district's headquarters is in Chautara. In 2006, 336,478 people resided in 79 village development committees, in 2011 there were 287,798.

#### **Program**

On July 19, 2017, Sindhupalchowk District Chapter conducted One Day Educational Program at Chautara. During the opening ceremony there were 96 participants from different walks of life were presented. The attendees were municipality chief, armies, APF, Ward chairpersons, police, Mayor and Deputy Mayor, NGOs, Medias, politicians and students etc.

Training was divided into two parts:

- 1. Opening ceremony and
- 2. Training session.

The opening ceremony was chaired by Mr. Yagya P Dangal district president of HURON. In this ceremony Chief Municipality Mr. Aman Sinha was the chief guest and guest of honor were Mr. Pitambar Pandey, Assistant chief district officer, Mayor and Deputy Mayor, representatives of political parties, students, campus and school teachers, journalists and civil society member were presented. Altogether there were 92 people in this opening ceremony. Besides Army Major, Police Inspector, National Investigation were represented. Among the representatives there were also some ladies.

In the training session altogether, there were 62 people participated. There were 45 males and 17 females at the training. Before this training, 40 people had no idea of any subject and had no training, 22 participants were familiar and after the training some of them had suggested to have 2 to 3 day training in the future.

The training templates were Fundamental rights, International laws and treaties, gentlemen's agreement, civil rights, federalism, crisis management and sustainable development goals. This year we have added a new topic which is sustainable development goals.
